RESOLUTION AUTHORIZING THE PURCHASE OF A 2026 PICKUP TRUCK

The Board of Trustees of Jersey Township, Licking County, Ohio met in a special meeting on January 9, 2026 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Jeff Fry, Vice-Chairman

Ben Pieper, Trustee

Trustee Wetzel moved the following:

WHEREAS, the Jersey Township Board of Trustees (“Board”) maintains a Capital Improvements Plan (“CIP”) for the planned purchase and/or rotation of township equipment; and

WHEREAS, the CIP anticipates the purchase of a new pickup truck for township official and employee use while performing township duties; and

WHEREAS, the Board has sought cost estimates for similar trucks through various manufacturers, and desires to purchase a 2026 Chevrolet Silverado 2500HD WT from Coughlin Chevrolet of Pataskala at state bidding price.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. Any Trustee, the Fiscal Officer, and/or the Administrator are authorized to execute any documents needed to effectuate the purchase of a 2026 Chevrolet Silverado 2500HD WT from Coughlin Chevrolet of Pataskala at state bidding price and as attached hereto as Exhibit A, up to the amount of \$60,000.00.

Section 2. The Fiscal Officer is authorized to expend up to \$60,000.00 from budget line #2031-330-750-0000.

Section 3. The Fiscal Officer and/or Administrator are authorized and directed to add the new pickup truck to the Township’s inventory and insurance policy. Authorized operators may be all elected officials and staff once added to the insurance policy.

Section 4. It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.

Section 5. This Resolution shall take effect at the earliest time provided by law.
