RESOLUTION DISPOSING OF TOWNSHIP PROPERTY BY INTERNET AUCTION

The Board of Trustees of Jersey Township, Licking County, Ohio met in a regular meeting on July 3, 2023 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Fry moved the following:

WHEREAS, the Board owns certain township personal property in the form of: one (1) used 1987 CASE 885 Tractor with ditcher attachment; one (1) used LANDA Heated Power Washer; two (2) used overhead garage door openers; one (1) used 250 gallon oil tank (steel); and one (1) used 250 gallon fuel tank (steel); and,

WHEREAS, the Board, pursuant to R.C. 505.10, is authorized to dispose of township personal property that is no longer needed for public use, is obsolete, or is unfit for the purpose for which it was acquired.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. That the Board of Jersey Township Trustees hereby determines that the following township personal property is no longer needed for public use, is obsolete, or is unfit for the purpose for which it was acquired: one (1) used 1987 CASE 885 Tractor with ditcher attachment; one (1) used LANDA Heated Power Washer; two (2) used overhead garage door openers; one (1) used 250 gallon oil tank (steel); and one (1) used 250 gallon fuel tank (steel).

Section 2. That the Board, pursuant to R.C. 505.10 (D), shall place the above referenced personal property up for auction on the Internet auction established previously by Township Resolution No. 23-07-03-02, adopted on July 3, 2023.

Section 3. It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.

Section 4. This Resolution shall take effect at the earliest time provided by law.

Trustee Wetzel seconded the Resolution and the roll being called upon its adoption the vote resulted as follows:



The motion carried and the Resolution was adopted.


