WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure; and

WHEREAS, the Board of Township Trustees of Jersey Township (the "Board") is planning to make capital improvements to: Burnside Road and Caswell Road culvert replacements; and

WHEREAS, the infrastructure improvements herein above described are considered to be a priority need for the community and is a qualified project under the OPWC programs.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

- Section 1. That Trustee Wetzel is hereby authorized to apply to the OPWC for funds as described above.
- **Section 2.** That Fiscal Officer Jesenko is authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.
- Section 4. This Resolution shall take effect at the earliest time provided by law.
