**RESOLUTION TO ACCEPT AN APPLICATION TO DESIGNATE PROPERTY AS A
REVITALIZATION DISTRICT WITHIN THE UNINCORPORATED AREA OF
JERSEY TOWNSHIP, LICKING COUNTY, OHIO, AND TO ORDER THE
PUBLICATION OF NOTICE OF THE APPLICATION, PURSUANT TO O.R.C.
§4301.81**

The Board of Trustees of Jersey Township, Licking County, Ohio met in a regular meeting on November 6, 2023 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Wetzel moved the following:

WHEREAS: on November 6, 2023, the Board of Trustees of Jersey Township, Licking County, Ohio (the "Board") received an application to designate property as a revitalization district (the "Jersey Township Revitalization District") within the unincorporated area of the township (the "Application"), pursuant to O.R.C. §4301.81, submitted by Steven R. Cuckler, Attorney on behalf of Gateway Community Improvement Corporation; and

WHEREAS: the Board has reviewed the Application and found it to meet the submission requirements set forth by O.R.C. §4301.81; and

WHEREAS: a copy of the Application for the proposed Jersey Township Revitalization District is attached hereto as "Exhibit A," and incorporated herein by reference, and conforms to all statutory requirements; and

WHEREAS: pursuant to O.R.C §4301.81, within thirty (30) days of receipt of an application, the Board must publish notice of the application for two (2) consecutive weeks in one (1) newspaper of general circulation in the township; and

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. The Board has found the application to designate property as a revitalization district (the "Jersey Township Revitalization District") within the unincorporated area of the township (the "Application"), pursuant to O.R.C. §4301.81, submitted by Steven R. Cuckler, Attorney on behalf of Gateway Community Improvement Corporation, to meet the submission requirements set forth by O.R.C. §4301.81.

Section 2. The Board authorizes and directs the Township Administrator to publish notice, within thirty (30) days of receipt of the Application, in the Newark Advocate newspaper for two (2) consecutive weeks, stating, among any other pertinent information, that the application is on file in the office of the Fiscal Officer and available for public inspection during normal business hours.




