### RESOLUTION APPROVING THE RENEWAL OF A HEALTH INSURANCE PLAN THROUGH WAYPOINT BENEFIT SOLUTIONS FOR CALENDAR YEAR 2024 AND AUTHORIZING PAYMENT OF PREMIUMS

WHEREAS, the Board of Township Trustees of Jersey Township (the "Board") has dental, vision, and received health insurance premiums quotes for calendar year 2024; and

WHEREAS, the renewal of insurance through United Health Care is proposed to be an increase of +/-12% to retain the same benefits as was in calendar year 2023, and dental and vision premiums include no increase from 2023 rates with the same coverage; and

WHEREAS, the Board desires to proceed with the renewal of dental, vision, and health insurance benefits through Waypoint Benefit Solutions.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. The Board authorizes the renewal of dental vision, and health insurance benefits through Waypoint Benefit Solutions.

**Section 2.** The Board authorizes and directs the Fiscal Officer to make payments available from Fiscal Year 2023 funds as follows:
