**Section 1.** That the Board of Jersey Township Trustees hereby determines that the following township personal property is no longer needed for public use, is obsolete, or is unfit for the purpose for which it was acquired: one (1) used Bandit brand brush chipper model number 58292-1-09-08.

**Section 2.** That the Board, pursuant to R.C. 505.10 (D), shall place the above referenced personal property up for auction on the Internet auction established previously by Township Resolution No. 24-01-03-12, adopted on January 3, 2024.

**Section 3.** It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.

**Section 4.** This Resolution shall take effect at the earliest time provided by law.


Trustee Fry seconded the Resolution and the roll being called upon its adoption the vote resulted as follows:


