**WHEREAS**, pursuant to Ohio Revised Code §109.43 and 149.43, elected officials are required to complete three hours of public records training for each term of office for which the officials are appointed or elected; and

**WHEREAS**, pursuant to Ohio Revised Code §109.43 and 149.43, elected officials may appoint a designee to attend the required public records trainings; and

**WHEREAS**, the Jersey Township Board of Trustees (the "Board") wishes to appoint a designee to attend the public records trainings, as required by law, for each Board member's current term of office.

**NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:**


**Section 3.** This Resolution shall take effect at the earliest time provided by law.


