**RESOLUTION TO ADOPT WITH MODIFICATIONS THE RECOMMENDATION OF

The Board of Trustees of Jersey Township, Licking County, Ohio met in a regular meeting on March 4, 2024 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Wetzel moved the following:

**WHEREAS**, the Board of Trustees (the “Board”) received a recommendation from the Zoning Commission regarding text amendments related to residential use of solar improvements; and

**WHEREAS**, the Licking County Planning Commission met on November 20, 2023 and made a non-binding recommendation to the Zoning Commission of Conditional Approval; and

**WHEREAS**, notice of the Jersey Township Zoning Commission hearing was placed in the newspaper on November 30, 2023.

**WHEREAS**, the Jersey Township Zoning Commission held a hearing on December 13, 2023 and made a recommendation of Approval to the Board of Trustees; and

**WHEREAS**, the Board of Trustees opened the hearing related to the rezoning on February 5, 2024, and tabled the hearing to March 4, 2024 at 7:30 p.m.; and

**WHEREAS**, the Board of Trustees continued the hearing related to the rezoning on March 4, 2024, and tabled the hearing to April 1, 2024 at 7:30 p.m.


