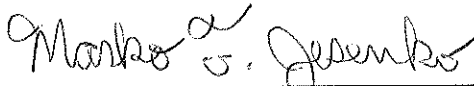
Section 3. This Resolution shall take effect at the earliest time provided by law.

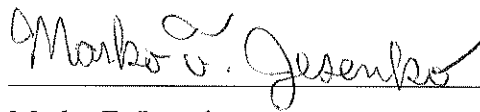
