**RESOLUTION TO APPROVE A COMMUNITY REINVESTMENT AREA
AGREEMENT PURSUANT TO LICKING COUNTY COMMISSIONERS'
RESOLUTION #119-304B**

The Board of Trustees of Jersey Township, Licking County, Ohio met in a special meeting on September 11, 2025 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Wetzel moved the following:

WHEREAS, on or about June 29, 2023, the Board of County Commissioners of Licking County, Ohio (“Commissioners”) authorized and created a Community Reinvestment Area within Jersey Township, pursuant to Commissioners Resolution #119-104B (the “CRA”); and

WHEREAS, pursuant to Section 4 of the CRA, the Board of Township Trustees of Jersey Township (the “Board”) shall negotiate and recommend to the Commissioners the terms of a CRA Agreement; and

WHEREAS, the Board hereby acknowledges and recommends the terms set forth in the draft Community Reinvestment Area Agreement and related School Compensation Agreements with the Northridge Schools and CTEC; and

WHEREAS, the Board recommends the approval of the Community Reinvestment Area Agreement by the Commissioners.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. That the Board approves and recommends to the Commissioners the Community Reinvestment Area Agreement, as attached hereto as Exhibit A.

Section 2. It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.

Section 3. This Resolution shall take effect at the earliest time provided by law.

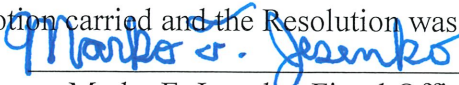
Trustee Fry seconded the Resolution and the roll being called upon its adoption the vote resulted as follows:

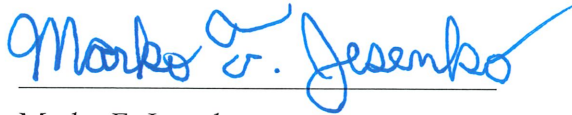
