RESOLUTION TO SET MEETING SCHEDULES AND NOTICE PROCEDURES

The Board of Trustees of Jersey Township, Licking County, Ohio met in an organizational meeting on January 5, 2026 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Wetzel moved the following:

WHEREAS, the Board desires to set its Regular meeting schedule for calendar year 2026; and

WHEREAS, the Board desires to set notification procedures for Special and Emergency meetings; and

WHEREAS, the Board desires to set the schedule for the 2026 end-of-year meeting, as well as, the 2027 Organizational Meeting.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. The Board shall hold its Regular meetings for 2026 on the first Monday of each month at 7:30p.m. at the township offices located at 1481 Mink Street. If a Regular meeting shall fall on an observed holiday, the Regular meeting shall be held on the following Wednesday at the same time and location.

Section 2. The Board shall post the notices for Special and Emergency meetings on the bulletin board at the township offices, as well as, on the township's website. Additionally, notices for required hearings shall be posted on the bulletin board at the township offices, as well as, on the township's website, or as otherwise required by law.

Section 3. The Board shall hold its annual end-of-year meeting on December 28, 2026 at 7:30p.m., unless otherwise cancelled prior to that date.

Section 4. The Board shall hold its 2027 Organizational Meeting on January 4, 2026 at 7:00p.m., with its January 2027 Regular Meeting to follow thereafter at 7:30p.m.

Section 5. It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.

Section 6. This Resolution shall take effect at the earliest time provided by law.


Trustee Pieper seconded the Resolution and the roll being called upon its adoption the vote resulted as follows:


The motion carried and the Resolution was adopted.
