RESOLUTION TO ADVERTISE FOR MATERIALS SUPPLIER

WHEREAS, the Board is in need of certain materials for road repair and general township maintenance; and

WHEREAS, the Board desires to purchase such materials from one or more suppliers, based on lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. The Board authorizes the Road Superintendent, Administrator, or Fiscal officer to seek sealed bids from suppliers of the following materials: #8 limestone; #57 limestone; #2 limestone, #411 and #304 limestone; D-rap limestone; #57 gravel; recycled asphalt; and pulverized topsoil.

Section 2. The Board will open the sealed bids at its February 2, 2026 Regular meeting. As such, the bids must be received no later than 12:00 noon on February 2, 2026.

Section 3. It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.


Section 4. This Resolution shall take effect at the earliest time provided by law.
