RESOLUTION DISPOSING OF TOWNSHIP PROPERTY BY INTERNET AUCTION

The Board of Trustees of Jersey Township, Licking County, Ohio met in a regular meeting on March 2, 2026 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Wetzel moved the following:

WHEREAS, the Board owns certain township personal property in the form of: one (1) Stihl chain saw model 025 with 18' bar and one (1) tandem axle trailer sixteen feet (16') in length; and

WHEREAS, the Board, pursuant to R.C. 505.10, is authorized to dispose of township personal property that is no longer needed for public use, is obsolete, or is unfit for the purpose for which it was acquired; and

WHEREAS, the Board has determined this equipment to be no longer needed for public use.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. That the Board of Jersey Township Trustees hereby determines that the following township personal property is no longer needed for public use: one (1) Stihl chain saw model 025 with 18" bar and one (1) tandem axle trailer sixteen feet (16') in length.

Section 2. That the Board, pursuant to R.C. 505.10 (D), shall place the above referenced personal property up for auction on the Internet Auction established previously by Township Resolution No. 26-01-05-11 adopted on January 5, 2026.

Section 3. It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.

Section 4. This Resolution shall take effect at the earliest time provided by law.
