RESOLUTION TO GRANT A PERMANENT AND TEMPORARY EASEMENT

The Board of Trustees of Jersey Township, Licking County, Ohio met in a regular meeting on March 2, 2026 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Wetzel moved the following:

WHEREAS, the Board owns the parcel identified as Licking County Auditor's Parcel Number 082-107466-05.000 and containing +/-2.0 acres; and

WHEREAS, the Licking Regional Water District has requested a thirty foot (30') wide permanent and ten foot (10') wide temporary utility easement across the road side of the property; and

WHEREAS, the Board agrees to the granting of the easement.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. That the Board of Jersey Township Trustees hereby grants a thirty foot (30') wide permanent and ten foot (10') wide temporary utility easement to the Licking Regional Water District applicable to Licking County Auditor's Parcel Number 082-107466-05.000.

Section 2. That the Board authorizes the Board President and/or Fiscal Officer to execute said easement as attached hereto as Exhibit A.

Section 3. It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.

Section 4. This Resolution shall take effect at the earliest time provided by law.


Trustee Pieper seconded the Resolution and the roll being called upon its adoption the vote resulted as follows:




