RESOLUTION AUTHORIZING TOWNSHIP ADMINISTRATOR AND FISCAL OFFICER TO ADVERTISE FOR BIDS FOR THE ROAD PROJECT INVOLVING CASWELL ROAD, HATCH ROAD, MEADOW ROAD, AND SYCAMORE LANE

The Board of Trustees of Jersey Township, Licking County, Ohio met in a regular meeting on May 4, 2026 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Wetzel moved the following:

WHEREAS, Jersey Township received an Engineer's Estimate from the Licking County Engineer for the resurfacing of Caswell Road, Hatch Road, Meadow Road, and Sycamore Lane; and,

WHEREAS, the Township has requested that the Licking County Engineer prepare a second Engineer's Estimate where Caswell Road and Hatch Road would still be resurfaced but Meadow Road and Sycamore Lane would be tarred and chipped; and,

WHEREAS, the Township has not yet received the second Engineer's Estimate; and,

WHEREAS, in order to not have to wait until the next Board meeting to begin advertising for bids, the Board wishes to authorize Administrator Rob Platte and/or Fiscal Officer Marko Jesenko to begin advertising for bids once the second Engineer's Estimate is received.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. That the Board hereby authorizes Jersey Township Administrator Rob Platte and/or Fiscal Officer Marko Jesenko to begin advertising for bids for the road project involving Caswell Road, Hatch Road, Meadow Road, and Sycamore Lane once the Township receives the second Engineer's Estimate.

Section 2. That the advertisement for bids shall be conducted in accordance with Ohio law, including but not limited to §5575.01 of the Ohio Revised Code.

Section 3. It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.

Section 4. This Resolution shall take effect at the earliest time provided by law.

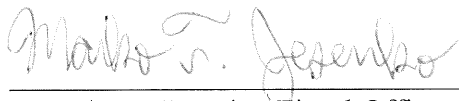

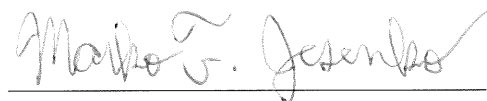
